

CONTINUING EDUCATION (CE) COMMUNITY SCHOLARSHIP

WINTER/SPRING 2025 APPLICATION

Completed applications must be received by JANUARY 8, 2025.

CE Community Scholarships are designed for those without access to other resources to fund their CE studies.

- Scholarships cover partial tuition only for one regular CE class or workshop for adults. (Master Classes, Studio/Critique, Studio Rental, Open Academy and other special programs are not eligible for scholarship assistance.)
- The remaining balance must be paid prior to the first class.
- Recipients are responsible for supplies required for their selected class. Course supply lists are available online (https://pafa-ce.coursestorm.com, attached to course descriptions) or available upon request.
- Scholarships may be transferred from one class to another in the event of a cancellation, but cannot be transferred from one semester to another.
- Scholarship awards may not be transferred from one individual to another.
- First-time applicants may receive priority for scholarship awards.
